THE CIVIL RIGHTS PROJECT (THE CRP) FOCUSES ON ENDING DISCRIMINATION BASED ON SEXUAL ORIENTATION. MORE SPECIFICALLY, THE CRP IS WORKING TO BRING MARRIAGE EQUALITY TO ALL NEW ENGLAND STATES, TO END FEDERAL DISCRIMINATION AGAINST LEGALLY MARRIED SAME-SEX COUPLES, AND TO ENSURE THAT GAY AND LESBIAN FAMILIES RECEIVE THE RESPECT AND RECOGNITION ALL FAMILIES RECEIVE, WITH A PARTICULAR EMPHASIS ON PARENTING ISSUES. THE CRP IS EXPANDING ITS WORK ON YOUTH ISSUES WITH ITS NEW YOUTH INITIATIVE. THROUGH THIS INITIATIVE, GLAD WILL WORK ON ISSUES SUCH AS THE HARASSMENT OF LESBIAN, GAY, BISEXUAL AND TRANSGENDER (LGBT) YOUTH IN AND OUT OF THE SCHOOL SETTING, STUDENTS' RIGHT TO ESTABLISH GAY/STRAIGHT ALLIANCES AND POLICY ISSUES AFFECTING YOUNG PEOPLE. THE CRP ALSO CONTINUES TO WORK ON EMPLOYMENT AND OTHER DISCRIMINATION

PUBLIC AFFAIRS AND EDUCATION PROVIDES INFORMATION AND EDUCATION TO THE GENERAL PUBLIC, DECISION-MAKERS, AND INDIVIDUAL CONSUMERS ABOUT THE LEGAL RIGHTS OF GAY, LESBIAN, BISEXUAL, AND TRANSGENDER PEOPLE, AND PEOPLE LIVING WITH HIV AND AIDS IN THE SIX NEW ENGLAND STATES. THE DEPARTMENT ACCOMPLISHES THIS GOAL THROUGH A VARIETY OF MEDIA, EVENTS, PUBLICATIONS, ONE-ON-ONE PHONE CONVERSATIONS, PODCASTS, AND VIDEOS DISSEMINATED ON THE INTERNET. IN FY12, FOR EXAMPLE, THE PUBLIC AFFAIRS DEPARTMENT HAD 58 EVENTS, INCLUDING WORKSHOPS ON LEGAL ISSUES, PUBLIC FORUMS, AND SPEAKING ENGAGEMENTS; DISTRIBUTED 15,800 COPIES OF PUBLICATIONS ON A VARIETY OF LEGAL ISSUES IN BOTH PRINT AND ELECTRONIC FORMAT; OUR WEBSITE HAD 111,667 UNIQUE VISITORS; ANSWERED 2,134 CALLS ON OUR LEGAL INFOLINE; AND WE PRODUCED 6 VIDEOS.

THE TRANSGENDER RIGHTS PROJECT (THE TRP) FOCUSES ON ENDING DISCRIMINATION BASED ON GENDER IDENTITY AND EXPRESSION. HAVING SUCCESSFULLY HELPED TO PASS LEGISLATION IN TWO NEW ENGLAND STATES THAT PROTECT PEOPLE FROM DISCRIMINATION BASED ON GENDER IDENTITY AND EXPRESSION (THREE STATES ALREADY HAVE HAD THOSE PROTECTIONS IN THE LAW), THE TRP IS NOW FOCUSING ON WORKING WITH ALLIES IN NEW HAMPSHIRE TO PASS LEGISLATION IN THAT STATE.
